

## AI Schedule

This AI Schedule ("Schedule"), together with either the CB Insights Terms of Service ("**TOS**") found online at <http://legal.cbinsights.com> or the electronically or manually signed master subscription agreement or similar binding services agreement in place between the customer listed below ("**Customer** or **Licensee**") and CB Information Services, Inc. ("**CB Insights**" or "**Licensor**") (the "**MSA**"), and any Order Forms or ordering documents, govern your use of the CB Insights AI offerings. All capitalized terms not defined herein shall have the meaning attributed to them in the TOS or MSA.

1. **Definitions.** "**AI Functionality**" means any generative tools, features, or functionality made available to you via the Licensed Materials and/or Services that utilize data models trained by artificial intelligence. AI Functionality is included in the definition of "Service" or "Licensed Materials" as set-out in the TOS or MSA, as applicable.
2. **Licensor's AI Functionality** Licensee is free to choose to use (and to continue to use or stop using) the AI Functionality made available by Licensor at its own discretion. The terms and conditions of this AI Schedule shall apply where the Licensee uses AI Functionality.
3. **Use Restrictions.** Notwithstanding anything to the contrary contained in the TOS, MSA, or any Order Forms, Licensee shall not, and shall cause its Users to not,
  - a. use the Licensed Materials or any Output in connection with the development of any software program, model, algorithm, or other generative AI tool, including training or teaching any large language model or other artificial intelligence algorithm.
  - b. to mislead any person or imply that Output generated using the AI Functionality is unique or solely human generated, or otherwise remove or alter any watermarks or metadata that may be generated with Output to identify Output as AI-generated;
  - c. in a manner which violates each respective subprocessor's terms or codes of conduct, or any content and use policies we may implement from time to time;
  - d. Use the Output or the AI Functionality in any manner that would or could qualify the AI Functionality as high-risk (or similar term) under applicable law; or
  - e. in a way that violates the Use Restrictions outlined in the TOS or MSA (as applicable).

#### 4. **Ownership and Use of Inputs and Outputs**

- a. Licensee acknowledges that all content or information submitted through use of the AI Functionality by or on behalf of Licensee ("**Inputs**") shall be Customer Data and that all content or other results generated by or on behalf of the Licensee's use of the AI Functionality ("**Outputs**") shall be considered CB Insights Property.
- b. Where Inputs and Outputs are submitted to a third party provider, those Inputs and Outputs may be retained temporarily by the third party provider as part of the operation of their service. However, Licensor shall contractually restrict any third-party provider of AI Functionality from using AI Inputs for: (i) training, (ii) otherwise improving its large language models or other services, and/or (iii) general use beyond the use required to provide and maintain the AI Functionality or as otherwise set out in this Schedule.
- c. To the extent required under applicable privacy laws, any third party provider of AI Functionality shall act as a Subprocessor of Customer Data submitted to the relevant AI Functionality, including Personal Data that may be contained in AI Inputs. All processing of Customer Data will be governed by the data processing agreement ("**DPA**") available at <http://legal.cbinsights.com> or the existing data processing agreement in place between Licensor and Licensee. In this Schedule, "Subprocessor" and "Personal Data" shall have the meanings given to them in the DPA.

5. **Third Party Terms.** AI Functionality may include features which are powered by AI models operated by a third party and Licensee may be required to comply with such AI model provider's code of conduct or acceptable use policy by using the AI Functionality. Licensee agrees to comply with [Microsoft's Code of Conduct for Azure OpenAI Service](#) and [Anthropic's Acceptable Usage Policy](#) and any other policy provided or made accessible by Licensor to Licensee.
6. **Risks and limitations.**
- a. Licensee acknowledges that Output may be inaccurate, include misleading results, and other CB Insights customers may receive similar or even identical Output from the Services.
  - b. Licensor does not warrant that any Output is accurate, complete, reliable, current, or error-free. Licensee is responsible for determining the accuracy and suitability of the Output. Neither Licensor nor its third party providers are responsible for any damages or losses arising from any use of any Output. Licensee agrees that any use it makes of the Output is at Licensee's own risk.
  - c. Licensee is solely responsible for the accuracy and quality of any Inputs and any decision, action or omitted action based on any Outputs.
